Part A: Pupil premium strategy plan

Statement of intent

Broadacre Primary School is situated in the City of Hull and serves the Bransholme and Kingswood housing estates. Kingswood is undergoing a major house building programme and school numbers have risen sharply in recent years. The school moved into a brand-new school building on the current site in February 2022. Eligibility for free school meals has dropped very in recent years – 32.9% in 2015 – 2016 to 25.7% in 2021 – 2022 and 21.14 in September 2024. 38% of pupils live in the 20% most deprived households nationally. This has dropped from 41% in 2021.

The school's most important priority is to close the attainment gap between our disadvantaged pupils and others within school and nationally. Our aim is to enable all pupils to fulfil their educational potential.

Our guiding principles for allocating our funding align with those identified in [Education Endowment Foundation - Using your Pupil Premium Funding effectively](#)

1. Schools can make a difference in narrowing attainment gaps – this means all staff in our school know who our disadvantaged pupils are and work collaboratively to narrow the gaps.
2. Evidence-informed teachers and leaders must combine research findings with professional expertise to make decisions – we will adopt approaches which evidence shows has been effective in other schools and which we believe are transferrable into our school
3. Quality First Teaching helps every child – quality first teaching must be at least good at all times for all children – this means investing time in supporting and developing staff at all stages in their careers
4. Less is more – we will focus on a small number of carefully chosen priorities identified through diagnostic assessment
5. Whilst we understand that pupils who are eligible for the Pupil Premium are more likely to be 'low-attainers', tackling the consequences of deprivation and using our funding effectively also means ensuring that middle and higher attaining pupils continue to achieve well and fulfil their potential

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Raising pupil numbers has led to an increase in classes in the school and the employment of newly qualified teachers. 36% of the teaching staff are in the first three years of their teaching career.
2	Internal and external data shows that there are gaps in knowledge and skills between our disadvantaged pupils and others in reading, writing and maths. The gap between disadvantaged and non-disadvantaged pupils is higher than in statistical neighbouring schools.
3	Attendance and punctuality Attendance is below the NA and there are still disparities between our disadvantaged pupils and their peers: 2023-24: <ul style="list-style-type: none">• Overall attendance – disadvantaged pupils 92.55% others 95.94%• Persistent absence – disadvantaged pupils 21.62% others 9.33%

4	Capacity of parents to support learning and promote pupil well-being. Since the beginning of the pandemic, the number of pupils accessing a social worker or early help practitioner has risen from 10 to 31. This has led to a significant impact on the well-being and resilience of groups of pupils, which has impacted on pupils' ability to achieve in school.

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2023 to 2024 academic year.

<p>Good Level of Development- EYFS 75% of pupils in FS2 achieved GLD compared to 67.7% nationally. The gap between disadvantaged and non-disadvantaged pupils at Broadacre was 18%. The GLD gap between disadvantaged pupils at Broadacre (68%) and non-</p>

disadvantaged pupils nationally (72%) was 4%, which indicates that the school gap is narrower than that seen nationally (20%)
The GLD gap between disadvantaged pupils at Broadacre (68%) and non-disadvantaged pupils nationally (72%) was 4%.

Phonics - Year 1

National outcome was 80%

81.1% of Broadacre Year 1 pupils passed the Phonics Screening Check. This is in comparison to 80% of pupils nationally.

Outcomes for disadvantaged pupils at Broadacre was 78% compared to non-disadvantaged pupils nationally (84%). This means that the attainment gap is 6% compared to a national gap of 16%.

End of KS 2 Data- Reading, Writing and Maths Combined.

75% of Broadacre Year 6 pupils met the expected standard in reading, writing and maths combined compared to the national figure of 61% Nationally, 67% of non-disadvantaged pupils met the expected standard in reading, writing and maths combined. At Broadacre, 80% of disadvantaged pupils met the expected standard in reading, writing and maths combined, meaning that, for that cohort, the attainment gap had been eradicated by the end of Key Stage Two.

End of KS 2 Data- Reading

78% of Broadacre Year 6 pupils met the expected standard in reading compared to the national figure of 74% Nationally, 78% of non-disadvantaged pupils met the expected standard in reading. At Broadacre, 80% of disadvantaged pupils met the expected standard in reading, meaning that, for that cohort, the attainment gap had been eradicated by the end of Key Stage Two.

End of KS 2 Data- Writing

79% of Broadacre Year 6 pupils met the expected standard in writing compared to the national figure of 73% Nationally, 79% of non-disadvantaged pupils met the expected standard in writing. At Broadacre, 80% of disadvantaged pupils met the expected standard in writing, meaning that, for that cohort, the attainment gap had been eradicated by the end of Key Stage Two.

End of KS 2 Data- Maths

82% of Broadacre Year 6 pupils met the expected standard in maths compared to the national figure of 72% Nationally, 78% of non-disadvantaged pupils met the expected standard in maths. At Broadacre, 80% of disadvantaged pupils met the expected standard in maths, meaning that, for that cohort, the attainment gap had been eradicated by the end of Key Stage Two.

Year 4 Multiplication Tables Check Results

70% of Year 4 pupils at Broadacre scored 25 out of 25 in the Multiplication Tables Check compared to 34% nationally. The average score on the check at Broadacre was 23.8 compared to 20.6 nationally.

Nationally, 37% of non-disadvantaged pupils scored 25 out of 25. 60% of disadvantaged pupils at Broadacre scored 25 out of 25. Furthermore, the average score for non-disadvantaged pupils nationally was 21.3. Disadvantaged pupils at Broadacre scored an average of 23. For this cohort, the attainment gap had been eradicated.

Emotional well-being and Mental Health of pupils.

Levels of parental engagement in school activities, parent evening attendance and return of homework, has risen in 2022 – 2023 by 9%

Internal and external monitoring shows that children settle quickly into school / lessons and disruptions are a rarity. (lesson observations and learning walks by school and MAT)

Internal and external monitoring supports these judgements.

ELSA trained TA worked with 26 children.

Attendance and absence, including those deemed to be persistent absentees

Our attendance for 2023 – 2024 overall was – 94.9% and there are disparities between our disadvantaged pupils and their peers.

Overall attendance – disadvantaged pupils 92.73% others 95.25% (gap 2.52%)

Persistent absence – disadvantaged pupils 21.32% others 9.62% (gap 11.7%)

Additional Activity

The school's Pupil Premium Strategy will be enhanced by other initiatives and plans from the School Improvement Plan which are not funded by pupil premium or recovery premium.

- Promoting reading for pleasure. The school's reward system incorporates a book vending machine. Pupils are given a token to choose their own book.
- Further developing the curriculum by refining intent documents and planning enrichment activities.
- Promoting the personal development of all pupils.
